RE: RECOMMENDATIONS AND ANNUAL REPORT FROM CHANCELLOR'S ADVISORY COMMITTEE ON STUDENT SERVICES AND FEES

The Chancellor's Advisory Committee on Student Services and Fees (CACSSF) respectfully submits this annual report as a summary of key student fee issues from 2015-16. **Specific recommendations on allocations of new Student Services Fee funding and Miscellaneous Student Fees are in bold.**

Background

The Chancellor's Advisory Committee on Student Services and Fees (CACSSF) was convened in 2006. The committee regularly advises the Chancellor and senior administration on student services funding and fee issues. The committee supports students through multi-year planning, closer partnerships with administration, and a coordinated process on student fees. CACSSF's voting membership includes nine student representatives (three each from the ASUC, Committee on Student Fees and Graduate Assembly), six representatives from campus administration, and two Academic Senate-appointed faculty members.

Student Services Fee

CACSSF strongly recommends that newly available recurring Student Services Fee funds be allocated as follows with funding beginning on July 1, 2016:

Background

The Student Services Fee (SSF), like tuition, is set by the Regents. Per UCOP policy, SSF revenue "shall be used to support services and programs that directly benefit students and that are complementary to, but not a part of, the core instructional program. These services and programs include, but are not limited to, operating and capital expenses for services related to the physical and psychological health and well-being of students' social, recreational, and cultural activities and programs; services related to campus life and campus community; technology expenses directly related to the service; and career support."

During 2015-16, SSF was increased by 5% systemwide. Per UCOP, the additional funds were to be allocated as follows: one-third return to financial aid, one-third to student mental health services approved by UCOP, and one-third to other critical student services. CACSSF conducted a thorough, two-step proposal process for the new \$600,000 in recurring funding available for critical student services. The committee prioritized programs and projects that have an established track record of effectively providing services to students.

This fall, CACSSF also distributed \$500,000 in one-time funding from its annual discretionary funds allocation to support student service initiatives. Between the two proposal processes, committee members devoted over thirty hours each to this process.

Miscellaneous Student Fees (MSF)

There were two requests for new miscellaneous student fees (MSF), two proposals for increases and one request to eliminate a fee. **CACSSF recommends the following actions:**

Background

MSF are fees and service charges that may be assessed to students for purposes such as: covering the cost of non-instructional services or materials; encouraging compliance with administrative rules; replacing or repairing equipment damaged by students beyond normal wear and tear; recovering costs through rental charges for student use of University-owned tools, musical instruments, or other equipment; or covering the cost of other materials or services necessary to provide a special supplemental educational experience of direct benefit to the student.

Campus-Based Fees

Campus-based fees are mandatory fees charged to all students. With the exception of the Life Safety Fee which does not require a vote by students, campus-based fees are voted on during student referenda and ultimately must be approved by the Chancellor and UCOP.

During April 2016, students approved two potential fee referenda. The following two were approved by students:

- The Ink Initiative Student Fee will provide operating costs to the Daily Californian. This \$2.50 per semester fee will replace the current \$2 fee.
- As a result of renewal, The Green Initiative Fund (TGIF) will continue to fund projects that
 improve and support campus sustainability efforts in areas such as transportation, energy and
 water efficiency, habitat restoration, environmental and food justice, and waste reduction.

Assuming your approval and that of UCOP, collection of these fees will begin in fall 2016.

Course Materials and Services Fees

The Course Materials and Services Fees (CMSF) Committee recommends fee proposals to the Chancellor. Currently, we have 102 approved CMSF's across 17 departments. For 2016-17, the committee is recommending increases to thirteen existing fees, the creation of two new fees, and the decrease of two existing fees. The Budget Office will transmit those recommendations from the CMSF Committee separately.
