**RE: RECOMMENDATIONS AND ANNUAL REPORT FROM CHANCELLOR'S ADVISORY  
COMMITTEE ON STUDENT SERVICES AND FEES**

The Chancellor's Advisory Committee on Student Services and Fees (CACSSF) respectfully submits this annual report as a summary of key student fee issues and recommendations from 2018-19. **Specific recommendations requiring approval are in bold.** Following your approvals, the Office of the CFO will communicate with UCOP as appropriate.

Background

The Chancellor's Advisory Committee on Student Services and Fees (CACSSF) was convened in 2006. The committee regularly advises the Chancellor and senior administration on student services funding and fee issues. The committee supports students through multi-year planning, closer partnerships with administration, and a coordinated process on student fees. CACSSF's voting membership includes nine student representatives (three each from the ASUC, Committee on Student Fees, and Graduate Assembly), six representatives from campus administration, and two Academic Senate-appointed faculty members.

CACSSF Recommendations

**1) CACSSF strongly recommends that \$1,097,038 in newly available Student Services Fee (SSF) funds be allocated on a recurring basis to the items in Attachment A with funding beginning on July 1, 2019.**

**2) CACSSF recommends three changes to the [Berkeley Campus Guidelines for Establishing, Increasing, Reducing or Eliminating Campus-Based Fees](#) as outlined in Attachment B.**

**3) CACSSF recommends the approval of the Miscellaneous Student Fee (MSF) action in Attachment C to increase the College of Engineering Maker Pass Fee.**

4) As detailed in our letter to you in November 2018, CACSSF voted against the adoption of the Miscellaneous Student Fee (MSF) proposed by the Berkeley International Office (BIO). We understand from a subsequent meeting with you in April 2019 that you received a proposal from the Vice Chancellor for Research that the one-year BIO MSF fee of \$56 be extended for an additional year. While a minority of CACSSF members appreciated the need for a temporary, one-year solution while the campus undertakes financial reform activities, the committee did not change its original recommendation.

5) As approved by the student body, three compulsory campus-based fees (the Recruitment and Retention Fee, the Educational Opportunity and Equity Fee, and the Campus Climate and Equity Fee) may request an annual inflationary adjustment, subject to review by CACSSF and your approval. The Recruitment and Retention Fee has requested an increase of \$0.50 per semester per undergraduate

student, and the Campus Climate and Equity Fee has requested an increase of \$0.75 per semester per undergraduate and graduate student. The Educational Opportunity and Equity Fee did not request a fee increase. **CACSSF recommends approving these increases as requested.**

CACSSF and Related Reviews

**6) As a new practice to improve oversight of student fees, CACSSF reviewed the proposed campus-based fee schedule for 2019-20.** The committee has no concerns regarding the fee schedule in Attachment D.

Additional Highlights

7) During 2018-19, CACSSF conducted two additional grant-making cycles and distributed approximately \$1.2 million dollars in one-time funding from its discretionary fund to support student service initiatives. In future years, CACSSF will continue to make decisions regarding its annual \$500,000 discretionary funding in spring so that funds will be allocated for the following fiscal year and thus reduce the need for carry forward requests from campus departments and student organizations. Funded projects are in Attachment E.

8) The Berkeley campus also provided a recommendation to the Associate Vice Chancellor and Dean of Students regarding the California Public Interest Research Group (CALPIRG) voluntary student fee. CACSSF recommended supporting CALPIRG's proposal that their annual pledge requirement of 10% of students be applied to undergraduates only with the stipulation that they actively target towards graduate students as well.

Background

The Student Services Fee (SSF), like tuition, is set by the Regents. Per UCOP policy, SSF revenue "shall be used to support services and programs that directly benefit students and that are complementary to, but not a part of, the core instructional program. These services and programs include, but are not limited to, operating and capital expenses for services related to the physical and psychological health and well-being of students' social, recreational, and cultural activities and programs; services related to campus life and campus community; technology expenses directly related to the service; and career support."

During 2018-19, SSF was increased by 5% systemwide through a state buy-out. Per UCOP, the additional funds were to be allocated as follows: one-third return to financial aid, one-third to student mental health services approved by UCOP, and one-third to other critical student services. This year, the VC Student Affairs, VC Equity and Inclusion, VC Undergraduate Education, and VP Graduate Studies identified critical student service funding needs and presented those to CACSSF.

CACSSF's recommendations above assist the student services VC/VPs in addressing budget improvement targets and meeting emerging student needs.

**Policy Revision Requiring Sunset Dates**

Berkeley Campus Guidelines do not currently require sunset dates for campus-based fees. CACSSF recommends requiring sunset dates for new campus-based fees moving forward.

**Policy Revision Regarding SFRC Composition**

CACSSF recommends the addition of a representative from the Division of Undergraduate Education to the Student Fee Referendum Committee (SFRC) and clarification of the non-voting status of the co-chairs.

In May of each year, the current membership of the SFRC will forward to CACSSF their recommendation for the incoming co-chair, who will serve at the pleasure of CACSSF.

**Policy Revision Regarding Consultation with Central Resource Management**

Currently, fee sponsors are not required to consult with Central Resource Management (CRM) as part of the fee referendum proposal process. CACSSF recommends requiring meetings with CRM and other relevant stakeholders as a best practice.

Referendum Process (p. 6)	<u>Fee Referendum Proposal</u> A Fee Referendum Proposal is a working document that ultimately results in the complete referendum text, the ballot language, and in the case of department-initiated fee referenda, the marketing plan and its budget. The sponsors should consult the ASUC, Graduate Assembly, campus departments and student groups who may be impacted by the fee for input, as well as Central Resource Management to develop their budget. Sponsors must present their fee proposal to the SFRC (see Addendums B and D for fee proposal content information) by November 1 for student-initiated referenda and by March 1 for department-initiated referenda.

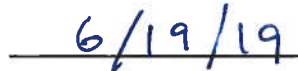

2. **Recruitment and Retention:** increase is recommended by Student Oversight Committee based on City of Berkeley's Annual General Adjustment Index; reviewed by CACSSF; and approved by the Chancellor
3. **Campus Health Care:** increase is recommended by Health Fee Advisory Board based on annual US BLS inflation rate for physician and clinical services and approved by VC Student Affairs
4. **Daily Cal INK Initiative:** increase is recommended by Office of the Registrar (OR) based on the annual CPI-SF rate and approved by CACSSF. Given the small fee level, OR recommends that an inflation factor be applied using a compounded inflation rate, rounding to closest \$0.25
5. **Wellness:** increase is recommended by the Wellness Fund Advisory Committee (WFAC) based on multiple inflation rates; reviewed by CACSSF; and approved by VC Student Affairs per Delegation of Authority memo dated August 12, 2019
6. **Educational Opportunity & Equity:** increase is recommended by Fee Oversight Committee up to 3% per year to adjust for inflation; reviewed by CACSSF; and approved by the Chancellor
7. **Campus Climate & Equity:** increase is recommended by the ECE Fee Advisory Board up to 3% based on CPI-SF rate; reviewed by CACSSF; and approved by the Chancellor
8. **Housing Security:** increase is recommended by Housing Initiative Student Fee Oversight Board up to 2.8% per year for inflation and approved by the Chancellor. Given the small fee level, CBO recommends that an inflation factor be applied using a compounded inflation rate, rounding down to closest \$0.25 per semester. The Summer 2020 fee level has been rounded down to a whole dollar amount, from \$4.25 to \$4.00, to avoid complications with financial aid packs Summer students
